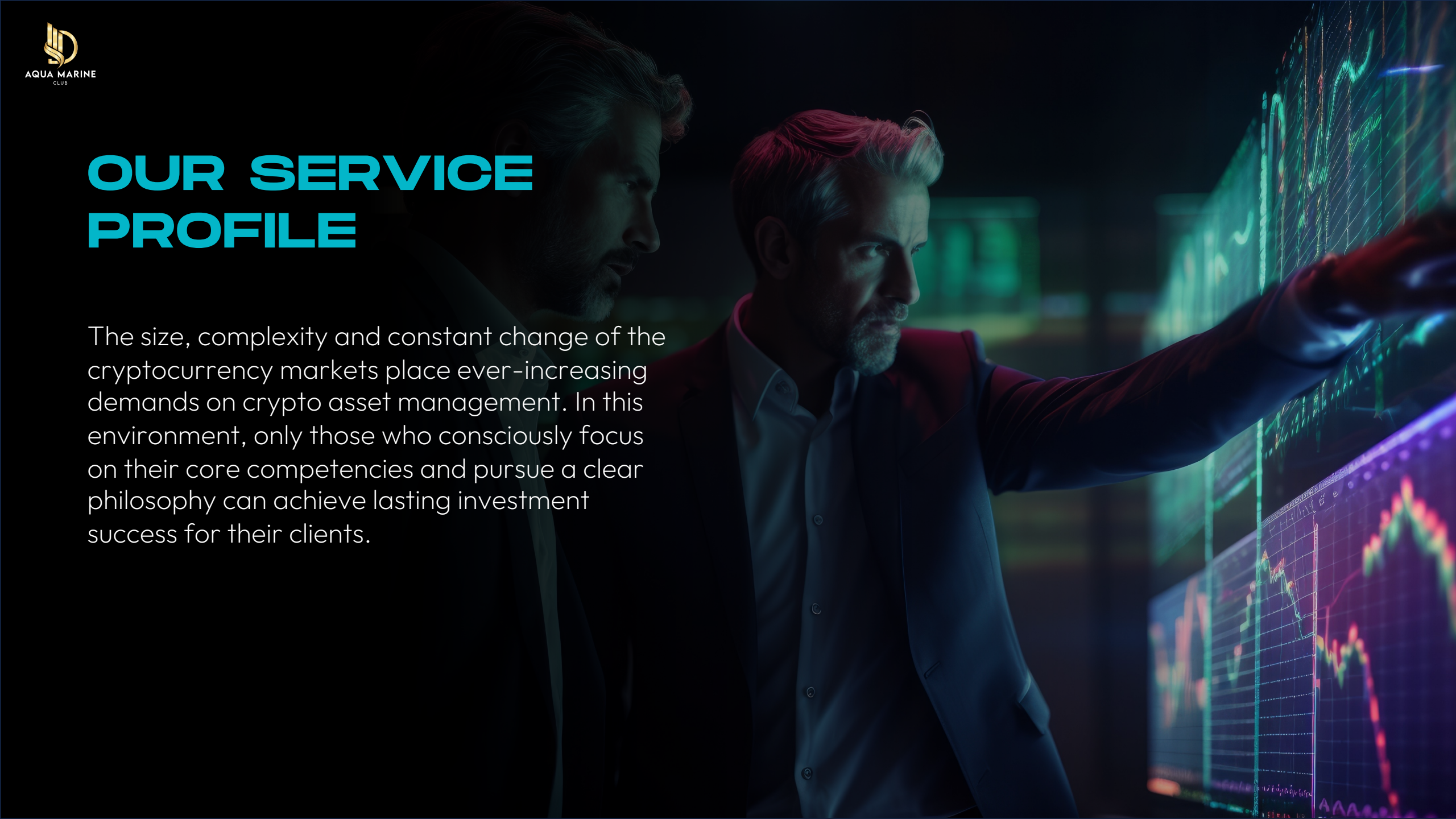

Our system manage risks by setting up parameters for crypto arbitration, specifies the minimum and maximum percentage of profitability, the trading amount, and the minimum balance value in coins.

Importantly, our arbitrage bot will not execute a transaction if the potential operation doesn't meet the specified parameters and doesn't offer the desired profit to the system

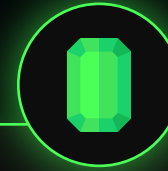

COMMISSIONS ON RE- INVESTMENT EXPLAINED

- Users earn commissions (All levels) from both re-investment and top ups made by their downlines, e.g. level 1 - 10% level 2 - 5% level 3 - 2.5% all the way down to the seven levels
- Re-investment and top ups made by downlines automatically adds or reflects on their sponsors Referral turnover according to the % of the referral turnover distribution , e.g Mr John reinvest or tops off \$100 to his active plan, the level one sponsor gets 100% of the top up amount (\$100) added to their referral turnover, level two sponsor gets 50% (\$50) and level 3 sponsor gets 25% all the way down to the seven levels respectively.

Rank commissions and Residual bonuses explained
